To find the result on the websites the candidates are advised to search by keying-in their **Application Sl. No.** and **Date of Birth** with selection of their **permanent District/State**.

The shortlisted candidates will have to appear at the Physical Measurement Test (PMT) and Physical Efficiency Test (PET) scheduled to commence on and from **08.01.2026 tentatively**. The Admit Cards for PMT & PET can be downloaded through the link ([wbprb.applythrunet.co.in](http://wbprb.applythrunet.co.in)) provided in the websites of **West Bengal Police Recruitment Board (<https://prb.wb.gov.in>)** and **West Bengal Police ([www.wbpolice.gov.in](http://www.wbpolice.gov.in))** from **02.01.2026**. Before downloading the Admit Card, candidates must upload their relevant documents which were asked to keep ready vide **Notice No. WBPRB/NOTICE - 2025/22 (CONS.\_WBP\_24) dated 17/11/2025**.

The candidates shall have to produce the printout of their admit card to get admittance into the PMT & PET arena. Candidates are advised to follow the instructions on their admit card and visit the above-mentioned websites for further update.
